VENDOR RULES for the International Pagan Coming Out Day

Broad Ripple Park

1550 Broad Ripple Avenue, Indianapolis, IN 46220

Definition: Vendor – a business that provides services or sells products for a fee.

Vendors must provide all items needed for their business (tables, chairs, water, etc)

All Vendors must comply with fire, health safety and other applicable laws, rules and regulations, including, but not limited to the rules of Broad Ripple Park itself. **web site IE link to park rules***

Space dimensions 10X10

A space cannot be sublet or given to another party without the prior written consent of the IPCOD committee.

Vendors shall keep their space and the area surrounding, free of litter and trash at all times.

NO rain date. No refunds.

IPCOD and its agents, volunteers and organizers shall not be liable for any of the following: theft, damage either to persons or property sustained by the vendor or any other person, low sales, injury, breakage of merchandise or any other incidents that may occur while vending at this May 12th, IPCOD Event.

Vendors are responsible for all necessary permits and insurance needed for vending. This includes all body work vendors. Food vendors must submit a copy of their Marion County food license with their application.

Vehicles MUST be removed from the festival area (to the parking area) no later than 10:45 AM. Vehicles cannot be brought to the festival area for removal of merchandise or event tear down until 5:05 PM.

The Indy Parks system requires that all swords, daggers or weapons of any kind must be kept in a sheath or wrapped in protective wraps until sold. The vendor must inform the purchaser that all weapons purchased must be immediately taken to their vehicle and locked into their vehicle. NO drawn weapons (other than for ritual) will be allowed in the park at any time. Every vendor selling weapons of any kind must post a visible 8" x 10" sign outlining this purchase policy.

The IPCOD committee reserves the right to require removal of any advertising or merchandise we consider offensive.

Disregarding or ignoring any terms of this agreement are immediate grounds for suspension of VENDOR sales and privileges.

Payment for booth space constitutes your acceptance of the terms and conditions contained herein.
